1. Introduction

1.2. INDICATIONS OF USE

The Insight Infrared Video Goggles are intended for viewing and recording eye movements in support of identifying vestibular disorders in patients. The device is intended for use only by a trained healthcare professional in an appropriate healthcare setting. This device provides no diagnoses nor does it provide diagnostic recommendations. The target population is 12+ years of age.

1.3. PRODUCT DESCRIPTION

The system consists of a head-mounted goggles made up of modular units including a body unit, removable front cover (camera unit), two infrared video cameras inside the camera unit, cable with two USB connectors, and an off-the-shelf (OTS) video viewing software application running on a clinician-supplied computer. The Insight Infrared Video goggles are designed to be used by clinicians to visualize and record eye movements with and without fixation. These goggles can be used wherever a clinician may need to examine a patient, including but not limited to hospitals, rehab facilities, outpatient clinics, urgent care centers, and patients' home environments.



The goggles are placed on the patient's head with the cameras facing the patient's eyes. The cameras illuminated with infrared light transmits a video signal of the eye movements to the computer screen for display. The computer uses an off-the-shelf video software Open Broadcaster Software (OBS) to allow for viewing and recording.

For this reason, an additional factor of 10/3 has been incorporated into the formulae used in calculating the recommended separation distance for transmitters in these frequency ranges.

c: Field strengths from fixed transmitters, such as base stations for radio (cellular/cordless) telephones and land mobile radios, amateur radio, AM and FM radio broadcast and TV broadcast cannot be predicted theoretically with accuracy. To assess the electromagnetic environment due to fixed RF transmitters, an electromagnetic site survey should be considered. If the measured field strength in the location in which the Insight Infrared Video Goggles is used exceeds the applicable RF compliance level above, the Insight Infrared Video Goggles should be observed to verify normal operation. 1.6. TRANSPORT, STORAGE, AND USE

STORAGE AND TRANSPORTATION CONDITIONS

We recommend the followings storage and transportation conditions to maximize the life of the Insight Infrared Video Goggles

- Packaged equipment should be stored in a wellventilated environment without corrosive gases.
- The equipment should be handled with care and kept away from rain and electrical shock during transportation.
- For short-distance handling, it is recommended that the Insight Infrared Video Goggles utilize the included case.
- For long-distance handling, it is recommended to be stored in a solid box with shock absorption and in a padded multi-layer corrugated box.

Below are the required operating conditions for transportation, storage, and use of the Insight Infrared Video Goggles. Usage outside of these ranges is not supported and can cause damage to the device.

1.7. CONTRAINDICATIONS, WARNINGS, CAUTIONS, AND RECOMMENDATIONS

CONTRAINDICATIONS

May be contraindicated in patients who exhibit a broken nose, recent face/ head trauma or surgery, or recent eye surgery. Immediately stop using the goggles if the patient shows any signs of allergy to the materials that comprise the goggles. Please consult a specialist in such circumstances before using the mask and strap on these types of patients.

GENERAL WARNINGS

- Inspect goggles upon arrival for any visible damage that may have occurred during shipping. Do NOT use goggles if there is visible damage to the USB connectors, cable, body unit, camera unit shell, or electrical (camera/infrared light bulbs/visible light bulb) components.
- Before using the goggles on a patient, please follow the Initial Setup & Checks in Section 4.1 to confirm that the goggles, computer, and software are functioning properly.
- This device contains camera equipment. Please handle it with care and do not drop the device.
- No modification of this equipment is allowed without manufacturer authorization.
- The system components should not be used or interchanged with components from infrared video goggles that are not manufactured by Vestibular First, nor should the components be interchanged with versions of goggles that are not made to be compatible with the Insight Infrared Video Goggles.

CLINICAL SAFETY WARNINGS

- Insight Infrared Video Goggles are to be used by trained personnel only, such as audiologists, ENT doctors, physicians, vestibular rehabilitation specialists, or licensed healthcare personnel with a similar level of qualifications. The device should not be used without the necessary knowledge and training to understand its use and how results should be interpreted.
- Use with caution for patients with blindness, strabismus/amblyopia, active infections, and ptosis. Please consult a specialist in such circumstances before using the goggles and strap on these types of patients.
- Only use the goggles on intact skin.



- Do not use these goggles for tests that are not appropriate to the functionality of the device (example: this version of the device cannot be used to test vHIT).
- Attend to the position of the cable to avoid patient and clinician entanglement, adjusting the cable position as needed during position changes or movement.
- Do not leave the patient alone while goggles are in place.
- Guide the patient verbally, guard closely, and as needed physically assist them with any position changes while they are in the dark environment of the goggles.
- Keep your hands close to the goggles during patient position changes, particularly if the top of the patient's head is toward the ground, to ensure the goggles remain secure.
- Always clean the goggles before each patient use, following the recommendations for cleaning in **Section 4.2**.
- The instrument is not protected against harmful ingress of water or other liquids. If any spillage occurs check the instrument carefully before use and if needed contact the manufacturer for service.
- Please transport, store, and use the Insight Infrared Video Goggles within the temperature and humidity restrictions listed in **Section 1.6** Transport, Storage, and Use. The manufacturer is not responsible for any damages incurred to the device if these restrictions are not followed.

ELECTRICAL SAFETY WARNINGS

- Do not plug the Insight Infrared Video Goggles USB connectors into any ports other than those on a laptop or personal computer.
- Handle the goggles with care. Do not drop the components. Avoid other undue impacts to this device. If the system is damaged from being dropped or impacted, contact the manufacturer for repair. Do not use the system if any damage is suspected or if the system is showing visible damage. Contact the manufacturer immediately to inform them and to arrange for repair or replacement.
- If the camera unit or cable is damaged in such a way that electrical components are exposed, unplug the USB connectors from the computer or laptop. Wait at least 10 minutes before touching any damaged electrical parts. Use protective equipment and do not handle exposed wires, electrical components, camera chips, or light bulbs directly.
- Do not touch the camera chip if it becomes exposed. If it becomes exposed due to damage to the camera unit, disconnect the USB



cables and wait 10 minutes until handling the camera chip. Use protective equipment when handling the camera chip.

- The system must not be used in the presence of explosive or flammable gases.
- Follow local ordinances and recycling instructions regarding disposal or recycling of the device and device components.

CAUTIONS

- Proper use of this device depends on careful reading of this manual and all additional instructions and labels.
- Federal law restricts the sale, distribution or use of the system to, by, or on the order of a licensed medical practitioner.
- Allow the system to obtain room temperature before using the equipment. Any components that have been stored previously should be brought to room temperature before usage.
- Patients cannot use corrective eyeglasses when wearing the goggles, although corrective contact lenses can be worn.
- Patients should not wear makeup around the eyes.
- Clean the camera lenses in the camera unit according to the instructions in **Section 4.2**
- Manually adjusting any camera settings should be done under the guidance of the manufacturer. Any camera settings changed can be reset to defaults by disconnecting and then reconnecting the goggles' USB cables to the computer.

CYBERSECURITY RECOMMENDATIONS

Cybersecurity is important to manage when using the Insight Infrared Video Goggles. Keeping your computer updated is as important as keeping the goggles in good working condition. All computers are vulnerable to cyberattacks, and the proper precautions should be taken to ensure that patient privacy is protected–especially when saving videos. The Insight Infrared Video Goggles should not be used if the connected computer is known to be infected or compromised by a virus or malware. Contact our support team as soon as possible to troubleshoot potential security concerns. Please follow the below precautions to minimize your exposure to cybersecurity risks:



HARDWARE

- Keep all hardware on the computer updated and patched with the latest firmware and updates provided by the computer manufacturer
- All storage devices that contain recordings from the goggles should be encrypted in transit and at rest
- Prevent unauthorized physical access to your computer using locked doors, proper security practices, and awareness of your surroundings
- Limit physical access to the machine and if necessary in high traffic areas-do not expose any unnecessary ports
- Only allow authorized USB devices to connect to your computer at the hardware level
- Maintain updated BIOS and motherboard firmware
- Implement a strong BIOS password management system to secure hardware
- Provide physical locks on computers and their ports to minimize tampering
- Block any unknown USB devices from connecting to the computer
- Physically inspect web cameras and their connections to the computer to confirm there are no skimming devices that could intercept the USB signal
- Connect the cameras to only known and trusted USB hubs and/or dongles.
- Keep computers and connected systems secure by implementing NIST-validated procedures and recommendations
- Disconnect any computer known to have any security vulnerability and refresh to factory/organization defaults
- Do not save recordings to unsecured machines
- Do not leave laptops or tablets unattended
- Ensure storage of videos is HIPAA compliant
- · Confirm all computers, networks, and servers have their traffic encrypted

SOFTWARE

- Update OBS software only to verified versions listed on the Vestibular First (manufacturer) website and do not use unknown or untested beta versions
- Grant the minimum necessary rights for the shortest duration possible to the logged in user
- Limit access to computer through the authentication of all users



- Setup automatic timed method to lock the system when unused to prevent unauthorized access
- Limit administrative access and elevated privileges to separate administrative accounts to minimize the impact of viruses and malware
- Review communications from the manufacturer regularly to keep updated with any security news
- Utilize unique passwords across multiple systems
- Choose passwords that are difficult for brute force attacks to guess



1.9. PACKAGING INSPECTION AND SHIPPING BOX






2. System Overview

2.1. MODULAR GOGGLES

The **patented** Insight Infrared Video Goggles are composed of 4 modular sections. The overall size of the goggles and especially the cushion were designed to fit adolescents 12+ and adults.








Figure 2-2 - Sectional view of Pro modular goggles components





The **Camera Unit** as seen in **Figure 2-3** has a primary role of securing two USB 2.0 cameras and connecting them to a computer. The camera unit shell is made of protective and durable PC + ABS plastic and includes two switches and two spring-

activated buttons. The light switches turn on and off the visible light LEDs (one on the left, the other on the right) that are a part of each camera. The clinician can turn on each visible light switch to introduce light, which can assist the clinician in observing any differences in eye movements or appearance of the eye/pupil as compared to when each light is off.

Figure 2-4 The cable that exits the camera unit is over 12 feet long, and at the distal end splits into a Y with two separate USB connectors, one labelled Left and the other labelled Right. The clinician uses these to connect the goggles to a computer via standard USB 2.0 ports so that video data can be sent from the cameras to the computer.

The cover buttons as seen in **Figure 2-5** on the camera unit must be compressed on both sides in order to allow removal of the camera unit from the body unit. A clinician may want to remove the camera unit so that the patient is no longer in a darkened environment, giving them the opportunity to change positions safely for example.









The **Body Unit** connects all of the modular sections together through snap-fit, hook & loop, and spring-activated hook connections as demonstrated in **Figures 2-1 and 2-2**. The body unit provides a secure connection point from the straps all the way to the camera unit to assure a secure fit. It has hook adhesive strips (velcro) along the internal surface of the body unit to connect to the cushion. Additionally, the body unit has connection points to which the strap and camera unit can secure.

The Cushion in Figure 2-6 provides a comfortable and light-proof seal around the eyes with a continuous surface that wraps around the forehead and on the bridge of the nose. The cushion connects to the hook surface of the body unit with embedded strips of loop material. The cushion is the primary surface that contacts the patient's body.

PRO

The Insight Pro has an updated Body Unit to fit with the updated durable cushion. The updated Body Unit has rigid tabs with guide rails which are located on the lateral inside surfaces (one tab/guide rail on each side for a total of two on the Body Unit). The Insight Pro also has an updated (durable) cushion which has two cantilever snaps designed to fit into the guide rails of the rigid tabs on the Body Unit. The rigid tabs with guide rails and cantilever snaps replace the hook and loop attachment method used as the way of attaching the durable cushion to the Body Unit in the original Insight Infrared Video Goggles.

The **Strap** has two strap connectors that snap into a receiving section on the body unit. The connector can be released by pinching it with two fingers to allow for quick removal of the goggles if needed. **Figures 2-1 and 2-2** shows the strap has strap adjusters on each side to allow for tightening and loosening of the goggles during donning and doffing. The section of the strap that connects with the back of the patient's head is designed to improve the security of the strap with a split opening in the middle.




2.2. SOFTWARE

The software recommended for clinicians to use with the Insight Infrared Video Goggles is called Open Broadcaster Software (OBS). OBS allows clinicians to easily connect the cameras in the goggles and the optional external webcam to their computer and then arrange these camera views in multiple configurations using scene collection templates provided by Vestibular First. OBS allows clinicians to view and record eye movements viewed by the



infrared video cameras when a patient is wearing the goggles. Clinicians find additional functionality in the software by utilizing keyboard shortcuts within the OBS settings.



The main interface of OBS can be broken down into four main sections: Image Area, Scenes, Recording, and Settings.

Figure 2-6 - Overview of OBS User Interface

The **Image Area** is where the video from the cameras is displayed. If the clinician chooses to record the patient session, the image area is what is recorded to the file. Lastly, the image area is used to center the area of interest of the eye into the middle of the screen by clicking and dragging in the image area.

The **Scenes** area of OBS is used to select a layout of the video sources and labels. Vestibular First provides pre-built groups of scenes called scene collection templates. The scene collections are used to improve user experience and reduce setup time by



setting up the most commonly requested layouts. Additionally, each scene is associated with a keyboard shortcut to help the clinician navigate the scene options more easily. Table 10-1 shows the available options provided in the scene collection template.

A common action used during a patient session is **Recording.** The "Start Recording" button allows a clinician to start and stop a recording. Once clicked, this button converts to "Stop Recording" and can be selected to stop a recording. The recordings are saved as video files with the user-defined specifications set in Figure X.

In **Settings**, the clinician can control important aspects of software use. This includes the recording path or selection of the file/folder where video recordings will be stored.




Figure 2-7 - Overview of OBS User Interface

4. Using the Insight Infrared Video Goggles

4.1. INITIAL SETUP & CHECKS

Perform before each use of the goggles.


GOGGLES AND ROOM SAFETY INSPECTION:

- 1. Confirm the following on the Insight Infrared Video Goggles:
 - a. Cable and USB connectors are not damaged or frayed
 - b. Cushion is firmly in place on body unit
 - c. There are no loose materials within the body unit
 - d. There is no visible damage to the cushion, strap, body unit, and camera unit.
- 2. Arrange clinical space with the computer on a secure surface that is close enough to the exam table to avoid strain on the cable when the patient will have the goggles on their head.
- 3. If using a laptop or tablet computer, confirm it is on a stable flat surface and will not be susceptible to falling if the cable is stretched beyond the range of your movements.
- 4. Clinicians should attend to the cable position to avoid catching themselves or the patient on it.

DECIDE WHICH CUSHION YOU WILL BE USING WITH THE INSIGHT PRO.

If using a durable cushion on the Insight Pro:


- Remove any disposable cushion that is in place
- Face the durable cushion unit "right side up"





PRO

- Connect the durable cushion unit to the body unit by sliding the cantilever snaps of the durable cushion into the rigid tabs of the body unit
- Please note that the Insight Pro requires the use of both the updated body unit (with guide rails and rigid tabs) and



the updated durable cushion unit (with cantilever snaps). Do not try to place the updated durable cushion unit onto the original Insight body unit which does not have the guide rails and rigid tabs. Likewise, avoid placing the original durable cushion onto the updated body unit since the updated body unit is specifically designed to work with the updated durable cushion unit.

If using a disposable cushion on the Insight Pro:

- 5. Remove the durable cushion unit if currently attached to the updated body unit. When removing the updated durable cushion unit, ensure that the cantilever snaps on the updated durable cushion unit are pulled (toward the center or midline of the goggles) when releasing the snaps so they can then slide through the guide rails and off of the updated body unit.
- 6. Attach the disposable cushion to the updated body unit, aligning the edges. Press firmly along all of the edges of the cushion to ensure that it firmly adheres to the hook surface of the updated Body Unit.
- 7. Examine the disposable cushion you intend to use for its integrity. Do not use a torn or damaged disposable cushion.
- 8. Ensure any cuts or wounds on clinician's hands are properly bandaged so as to avoid contaminating the disposable cushion when handling it.







- 9. When removing the disposable cushion, it may be easiest to start at the widest section which would be either at the top or the lateral portions of the goggles. Pull the disposable cushion gently away from the hook surface of the Body Unit, trying not to tear the foam so that the cushion can be removed in one full piece if possible.
- 10. Use a new disposable cushion during every individual patient care session.

COMPUTER AND SOFTWARE SAFETY INSPECTION

- Confirm the correct screen resolution template is selected in the Scene Collection menu. If not, repeat the steps in Section 3.2 to import the correct scene collection.
- 2. Confirm both cameras are functioning and displaying video in the Both Eyes Scene. The performance in infrared LEDs can dim over time. Be sure to check that both eyes appear illuminated when assessing camera function.
- Confirm Left and Right eye videos match true Left and Right eyes. The L/R imprinted on the nose bridge of the goggles should match the camera video and be oriented correctly.









4.2. CLEANING AND DISINFECTING THE GOGGLES

Goggles must be cleaned and disinfected **before** and **after** each patient use. Below are general guidelines and cleaning recommendations:

General Guidelines

- Wash your hands before and after handling any parts of the goggles.
- The instrument is not protected against harmful entry of water or other liquids. If any liquid enters the openings on the camera unit, check the instrument carefully before use or contact the manufacturer for service.


GOGGLES CLEANING AND DISINFECTING STEPS

- 1. Wipe down all parts of the goggles in Table **4.2.1** with 70% isopropyl alcohol solution (30% purified water). Ensure removal of any debris as well as thorough wiping to disinfect.
- 2.Ensure a contact/treatment time of 5 minutes, following the recommendation of the cleaning and disinfecting product used.

4.3. CONSIDERATIONS PRIOR TO A PATIENT DONNING GOGGLES

Contraindications: May be contraindicated in patients who exhibit a broken nose, recent face/head trauma or surgery, or recent eye surgery. Immediately stop using the goggles if the patient shows any signs of allergy to the materials that comprise the goggles. Please consult a specialist in such circumstances before using the mask and strap on these types of patients.

PRIOR TO DONNING:

- Only use the goggles on intact skin.
- Explain to the patient the purpose of the goggles and what symptoms the patient may experience during testing while wearing the goggles.
- Reassure the patient that the clinician will remain present for safety throughout the testing and treatment procedures and that the patient can request removal of the goggles at any time.

CUSHION USE:


- Ensure the cushion used is lined up with the borders of the goggles and does not intrude into the interior of goggles.
- Ensure the hook and loop (Velcro) is firmly attached and no gaps between the cushion used and body unit.


PRO

IF USING THE DURABLE CUSHION ON THE INSIGHT PRO:

- Ensure that the cantilever snaps of the updated durable cushion unit are properly aligned such that they slide smoothly into the guide rails of the rigid tabs of the updated body unit. Do not misalign and then try to force the cantilever snaps onto the updated body unit.
- Please note that the Insight Pro requires the use of both the updated body unit (with guide rails and rigid tabs) and the updated durable cushion unit (with cantilever snaps). Do not try to place the updated durable cushion unit onto the original Insight body unit which does not have the guide rails and rigid tabs. Likewise, avoid placing the original durable cushion onto the updated body unit since the updated body unit since the updated body unit since the updated body unit is specifically designed to work with the updated durable cushion unit.







IF USING A DISPOSABLE CUSHION ON THE INSIGHT PRO, ENSURE THE FOLLOWING:

- Examine the disposable cushion you intend to use for its integrity. Do not use a torn or damaged disposable cushion.
- Ensure any cuts or wounds on clinician's hands are properly bandaged so as to avoid contaminating the disposable cushion when handling it.
- Use a new disposable cushion during every individual patient care session.

4.4. DONNING THE GOGGLES:

SAFETY REMINDERS:

- Always clean the goggles before each patient use, following the cleaning instructions in **Section 4.2**
- Always guard your patient and ensure their safety to avoid cable entanglement and to ensure they are able to move and change position safely while in the dark environment of the goggles.
- Ensure that the visual fixation light is "OFF" for both eyes prior to having the patient don the glasses unless desired "ON" at that time.



PRO

1. Ask the patient to remove any glasses.



2. Using the strap adjuster, loosen the straps of the goggles.

3. Place the goggles in front of the patient's eyes, with patient assistance if they are able. Place the strap behind the patient's head.





4. Using the strap adjuster, secure the strap comfortably but firmly enough to keep goggles in place over eyes.



5. To prevent slippage, ensure the silicone strap lies flat on the back of the patient's head and that the split strap opening is separated.

Note: Be sure to communicate with the patient to ensure comfort and appropriate level of tightening of the strap, such that it is secure but that the pressure from the goggles and strap on the patient's head is not considered significantly uncomfortable to the patient.



4.5. CENTERING THE EYES

A. CENTER LEFT EYE

- Press the number **1** on your keyboard to switch to the left eye master scene.
- Click and drag pupil of eye into the center of the preview window.




B. CENTER RIGHT EYE

- Press the number **2** on your keyboard to switch to the right eye master scene
- Click and drag pupil of eye into the center of the preview window.



C. CONFIRM BOTH EYES ARE CENTERED

- Press the number **3** on your keyboard to switch to scene with both eyes displayed.
- If you need to modify one or both eyes, return to the master scenes by pressing 1 and/or 2 and update the individual eye positions until they are in the correct position.



Note: You can only adjust the position of the eyes in Scene 1 and Scene 2.

4.8. HOW TO USE THE VISUAL FIXATION LIGHT

- Each eye has an independent visual fixation light and switch. Use one or both lights as desired.
- To operate the visual fixation light, locate the sliding switches at the top of the Insight Infrared Video Goggles.
- 1.To activate the visual fixation light, slide switch toward the ON label and confirm the patient can see the light.
- 2.To deactivate the visual fixation light, slight the switch toward the OFF label and confirm that the patient no longer sees the light.





4.9. HOW TO REMOVE AND ATTACH THE CAMERA UNIT

The camera unit (which contains the cameras) can be removed to allow the patient to see the room. This is advised at times when:

- The patient is changing position (such as repositioning between testing or treatment maneuvers).
- The patient indicates they need a break from the dark environment of the goggles between testing or treatment procedures.
- The clinician and patient agree that it is not necessary to fully remove the goggles from the patient.

Note: When the camera unit is removed, no viewing or recording of patients' eyes can occur since the cameras are inside of the camera unit.

REMOVING THE CAMERA UNIT

1. Simultaneously press both spring release buttons (there is one button on each side of the goggles).



2. Remove the camera unit by pulling it straight away from the body unit.

Always remember to place the camera unit in a secure location.





ATTACHING CAMERA UNIT

 Orient the camera unit so that the logo is upright, the cord is coming out of the bottom corner, and the ON/OFF light switches for the visual fixation light are on the top of the camera unit.



2. Press the camera unit onto the body unit with even and firm pressure. Confirm the camera unit is securely attached on both sides by ensuring that the camera unit does not move before proceeding with further use.





4.10. DOFFING THE GOGGLES

 Loosen the straps by lifting the tab. Slide the goggles off the head of the wearer, with the wearer assisting if able.



 If you want to remove the goggles more quickly, press both sides of the side release buckle (strap connector) to release the strap from its connection to the goggles on one side.



PRO

- 3. Cleaning considerations for the Insight Pro:
 - a. If using the durable cushion on the Insight Pro:
 - i. Clean and disinfect the updated durable cushion unit along with all other parts of the goggles as listed in Section 4.2 of this User Manual.
 - b. If using the disposable cushion on the Insight Pro:
 - i. Properly dispose of used disposable cushion in the standard waste container or in a biohazard container when appropriate



4.11. ACCESSING AND VIEWING RECORDED VIDEOS

Click File... Show Recordings

The menu is along the top of the screen. Click to select File and choose Show Recordings in the drop-down menu. Once Show Recordings is selected, a window will open showing you the location of your recordings.



4.12. ACCESSING AND VIEWING RECORDED VIDEOS

Videos can be played by a native video playback application provided with the operating system. Users can utilize additional 3rd party viewers, however Vestibular First does not support any applications for video playback. Please contact your IT professional for assistance in selecting and downloading any playback applications to ensure compatibility with your computer's operating system.

4.13. STORING YOUR GOGGLES

- 1. Unplug and store the goggles safely between uses. It is not recommended to leave the goggles plugged in continuously.
- 2. After cleaning the goggles based on the steps in Section 4.2, coil the cable starting at the USB plugs into a circle approximately 150mm (6") in diameter.
- 3. Place coil into the cutout in case
- 4. Place goggles into the case, with Vestibular First logo right side up and the part of the cable where it exits the camera unit pointing toward the bottom of the case. The face cushion area of the goggles should rest against the curved portion of the divider wall inside the case, and the goggles should be oriented as indicated by the molded outline in the bottom of the case.
- 5. Secure the lid of the case by zippering the case closed completely.



5. Troubleshooting, Repair, and Warranty

5.1. GOGGLES TROUBLESHOOTING

PROBLEM

Light leakage from around the cushion.

SOLUTION

- 1. Ensure the goggles are positioned firmly on the face of the patient and that the cushion is evenly positioned so that light is not visible leaking in from the edges of the goggles at any point.
- Ensure there is no damage to the cushion (tears, missing portions, or deformed shape). If the cushion is damaged, contact Vestibular First at Support@VestibularFirst.com or 215-667-8990 regarding how to obtain replacement parts.
- 3. Check the cushion to ensure there is no gapping between the cushion and goggles. If there is gapping, remove and reattach the cushion so that there are no gaps between the cushion and goggles.
- 4. Ensure the hook and loop is firmly attached to the cushion and the goggles.
 - a. If the hook and loop does not attach well even when firm even pressure is applied, inspect the hook (body unit) and loop (cushion) for debris or dirt that may be caught in the material.
 - b. Clean the cushion and body unit using the cleaning instructions provided in **Section 4.2.** If there is remaining debris stuck on the hook or loop material, remove it manually, then disinfect the surfaces.
 - c. If the hook and loop do not attach properly after these inspection and cleaning steps are completed, please contact the manufacturer for assistance.



If using the updated durable cushion unit:

PRO

 Check that your durable cushion is properly attached to the Body Unit. Make sure that the cantilever snaps on the durable dushion are engaged with the rigid locking tab and within the guide rails on the body unit.



If using the disposable cushion:

- 1. Examine the disposable cushion you intend to use for its integrity. Do not use a torn or damaged disposable cushion.
- 2. See **Section 4.1** on proper process for attaching the disposable cushion.
- 3. Ensure the goggles are positioned firmly on the face of the patient with strap effectively secured so that light does not leak in between the cushion and the patient's face.



PROBLEM

 $\ensuremath{``L'}$ and $\ensuremath{``R''}$ printed on the nose portion of the goggles are upside down.

SOLUTION

Detach and rotate camera unit (part which holds the cameras) 180 degrees. Re-attach camera unit. Confirm that L/R are now oriented upright when viewed on the software.

PROBLEM

Artifacts or static in the camera video.

SOLUTION

Unplug and replug in USB cables and ensure a proper connection.

PROBLEM

Visual fixation light does not light up when the switch is turned to "On."

SOLUTION

Ensure USB plugs are connected firmly so that the lights are getting power from the computer. The computer must be turned on as well.

Ensure there is no debris in the switch preventing it from moving to the "On" position. If there is debris, remove it.

PROBLEM

Video of the eye is colored and/or dim.

SOLUTION

- 1. Ensure the goggles are positioned firmly on the face of the patient and that the cushion is evenly positioned so that light is not visibly leaking in from the edges of the goggles at any point.
- 2. Ensure a good connection to the computer. Unplug and replug in USB cables and restart OBS.

PROBLEM

Left and Right eye are reversed (only occurs in Mac OS)*

***Note:** In this case, the right eye is labeled in the software as "Left" and the left eye is labeled in the software as "Right." This can be assessed by having the patient wear the goggles and looking to see if the physical "L" and "R" printed on the inside nose portion of the goggles matches with the video display labels of "Left" and "Right" in the software.

SOLUTION

Perform only those steps necessary to get the desired result of a Right and Left eye nose portion "L" and "R" to match with the software video displays labeled "Left" and "Right" respectively.

1. Unplug and left and right cables. Plug the right cable where the left cable was plugged in and the right cable where the left one was plugged in previously.



- 2. Restart OBS.
- 3. Restart computer, open OBS, and see if video is displaying.

PROBLEM

Video of left and right eye are not synchronized or freezing (lost frames)

SOLUTION

- 1. Check to see if the computer being used with the goggles meets the minimum hardware requirements.
 - a. Processor i5 or better with 2.0 ghz or higher
 - b. Memory (RAM) 8GB or more
 - c. Dedicated Video Card Not necessary, but preferred
- 2. If the computer does not meet the minimum hardware requirements, please either update that computer to meet the requirements or select a different computer to use with the goggles. If your computer meets the requirements, proceed to following steps.
- 3. Close any programs other than OBS to reduce the drain on the system's resources.
- 4. Restart your computer to clear any issues that may have resulted in system resources being drained even after all programs other than OBS are closed.
- 5. If you have a dedicated video card, there is a way in settings of OBS to transition the encoder from software to hardware, which may eliminate asynchronous or freezing video.



5.3. WARRANTY AND REPAIRS

Vestibular First warrants that the Insight Infrared Video Goggles are free from defects in material and workmanship under normal use and service for a period of 36 months from the date of delivery by Vestibular First. If the Insight Infrared Video Goggles require service during the applicable warranty period, the purchaser should communicate directly with Vestibular First. Warranty is not transferable to another entity and only covers the original purchasing entity.
